A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF TULPEHOCKEN, BERKS COUNTY, PENNSYLVANIA, APPOINTING LARRY DEAN MARTIN TO THE ZONING HEARING BOARD OF TULPEHOCKEN TOWNSHIP

WHEREAS, pursuant to the Pennsylvania Municipalities Planning Code, Section 903, the Board of Supervisors shall appoint residents of the municipality to the Zoning Hearing Board; and

WHEREAS, a vacant position exists on the Tulpehocken Township Zoning Hearing Board; and

WHEREAS, the Board of Supervisors of Tulpehocken Township desires to appoint Larry Dean Martin to the Tulpehocken Township Zoning Hearing Board to fill a vacant position on the Zoning Hearing Board; and

WHEREAS, the term of the vacant position was for a three-year term that commenced on January 1, 2014 and will expire on December 31, 2016; and

WHEREAS, pursuant to Section 903 of the Pennsylvania Municipalities Planning Code appointments to fill vacancies on a Zoning Hearing Board shall only be for the unexpired portion of the term of the vacant position; and

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the Pennsylvania Municipalities Planning Code, Section 903, that the Tulpehocken Township Board of Supervisors resolves as follows:

- 1. Larry Dean Martin, a resident of Tulpehocken Township, shall be appointed to the Tulpehocken Township Zoning Hearing Board for the remainder of the term of the vacant position and
- 2. Larry Dean Martin's term on the Zoning Hearing Board for Tulpehocken Township shall commence immediately upon adoption of this Resolution and expire on December 31, 2016.

FURTHER RESOLVED, that this Resolution shall take effect immediately, or as soon as legally permissible thereafter.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Tulpehocken Township that this Resolution would have been adopted had such

unconstitutional, illegal or invalid provision, sentence, clause, section, or part not been included herein.

FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.
