## **RESOLUTION NO. 2019-9**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF TULPEHOCKEN, BERKS COUNTY, PENNSYLVANIA AUTHORIZING BERKS EARNED INCOME TAX BUREAU TO COLLECT THE LOCAL SERVICES TAXES FOR TULPEHOCKEN TOWNSHIP

WHEREAS, pursuant to the Local Tax Enabling Act, 53 P.S. §690l et seq., the Board of Supervisors of Tulpehocken Township enacted Ordinance No. 2019-3 on November 13, 2019 establishing a Local Services Tax; and

WHEREAS, the Local Tax Enabling Act authorizes certain political subdivisions, including Tulpehocken Township, to provide by resolution for the appointment and compensation of a public or private agency for the assessment and collection of taxes imposed under the authority of that Act and such appointment shall continue in force without annual reauthorization unless otherwise repealed or revoked by the Township or unless otherwise provided for by the Act; and

WHEREAS, the Board of Supervisors of Tulpehocken Township believes that it is in the best interest of Tulpehocken Township to appoint Berks Earned Income Tax Bureau to collect the Local Services Tax for the Tulpehocken Township.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Tulpehocken Township that the following action is taken:

- 1. Berks Earned Income Tax Bureau is hereby appointed as Local Services Tax collector for Tulpehocken Township, Berks County, Pennsylvania;
- 2. Berks Earned Income Tax Bureau shall be compensated at the rate of 2.5% of the Local Services Tax collected, as may be amended by Resolution of Tulpehocken Township Board of Supervisors from time to time; and
- 3. The officers of Tulpehocken Township are authorized and directed to take all other actions necessary or appropriate to carry out the purposes of this Resolution.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Tulpehocken Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.

FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.

FURTHER RESOLVED, that this Resolution shall be effective immediately.
