A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF TULPEHOCKEN, BERKS COUNTY, PENNSYLVANIA ESTABLISHING THE TULPEHOCKEN TOWNSHIP UNIFORM CONSTRUCTION CODE BOARD OF APPEALS AND APPOINTING MEMBERS THERETO

WHEREAS, the Board of Supervisors of the Township of Tulpehocken, Berks County, Pennsylvania, enacted Ordinance Number 2004-2, electing to administer the Pennsylvania Construction Code, 35 P.S. § 7210.101 – 7210.1103 ("Act") and adopting the Uniform Construction Code, 34 Pa. Code, Chapters 401 – 405 (collectively, the "Code"); and

WHEREAS, Section 4 of Ordinance Number 2004-2 provides that a Board of Appeals shall be established by resolution of the Board of Supervisors of the Township in accordance with the requirements of the Code, and for the purposes set forth therein.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Tulpehocken, Berks County, Pennsylvania, that in accordance with Section 4 of Ordinance Number 2004-2 the Tulpehocken Township Uniform Construction Code Board of Appeals is hereby established.

FURTHER RESOLVED, the terms of office of each member shall commence on the effective date of their appointment and one member shall serve for one (1) year, one member for two (2) years and the third member for three (3) years with the term commencing with the first Monday in January next succeeding the date of adoption of this Resolution establishing the Tulpehocken Township Uniform Construction Board of Appeals and appointing its initial members.

FURTHER RESOLVED, thereafter the terms of office of each member of the Board shall be three (3) years and shall be fixed so that each term of office of one member shall expire each year.

FURTHER RESOLVED, members of the Tulpehocken Township Uniform Construction Board of Appeals shall be appointed by Resolution.

FURTHER RESOLVED, each member may continue to serve until their successor is appointed and may succeed themselves.

FURTHER RESOLVED, members of the Tulpehocken Township Uniform Construction Board of Appeals shall meet the criteria for members of the UCC Board of Appeals provided for in the Act and Code.

FURTHER RESOLVED, that in accordance with the requirements of the Code, the following persons are appointed to the Tulpehocken Township Uniform Construction Code Board of Appeals for the term noted:

Member	Term	Expiration of Term
Alan Bashore	One (1) Year	January 2022
Les Kegerreis	Two (2) Years	January 2023
Dale Stump.	Three (3) Years	January 2024

FURTHER RESOLVED, the date of expiration of the term in January of the year specified shall be the date of the reorganizational meeting of the Tulpehocken Township Board of Supervisors pursuant to the Commonwealth of Pennsylvania Second Class Township Code.

FURTHER RESOLVED, the Tulpehocken Township Uniform Construction Code Board of Appeals shall have the powers and authority granted it by the Act and Code.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this
