# **December 12, 2011 Board of Supervisors Meeting**

Chairman Kintzer called the regular meeting of the Township Board of Supervisors to order at 7:00 p.m. in the Tulpehocken Township Municipal Building. Those attending the regular monthly meeting were John Kintzer, Rick Kramer, Ron Whitmoyer, Kathy Boltz, Chad Hepler, Beth Auman, Gary Deck, Lester Feick, and other interested persons.

The meeting continued with the pledge to the American Flag.

### PUBLIC COMMENTS

Larry Martin from Dutch Valley Food Distributors Inc. submitted a letter to the Board of Supervisor's requesting to purchase an additional 8 EDUs to accommodate the growth at their facility. Dutch Valley is adding a food processing center to the facility. All three Board Members agreed to sell the 8 EDUs and directed the township Solicitor and Engineer to attend a meeting with Larry Martin to discuss the agreements and the purchase of the additional EDUs.

# APPROVAL OF MINUTES

Rick Kramer made a motion to approve the minutes from the November 14, 2011 Board of Supervisors meeting. Ron Whitmoyer second the motion, upon a roll call vote all three Board Members cast a yes vote.

## **ADMINISTRATIVE ACTIONS**

### Planning Commission Recommendations to the Board

No recommendations from the Planning Commission, they did not meet for the month of December due to lack of business.

**Camp Calvary** – Ron Whitmoyer made a motion to accept a time extension for review that will extend to March 13, 2012. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

**Glenn Hurst** – Mr. Hurst is requesting a reduction in the letter of credit for the poultry project. Township Engineer recommends reduction the letter of credit to \$5,400.00. Ron Whitmoyer made a motion to reduce the letter of credit to the terms in the October 10, 2011 Ludgate letter. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

#### 2012 Budget for Township and Sewer Funds

**2012 Budget Certification** – The proposed 2012 budget had been advertised as available for public inspection on October 26, 2011, after having been reviewed and preliminarily approved by the Board on October 18, 2011. The 2012 budget for all Township accounts, except the Sewer Service, proposes revenues of \$928,307.00 and expenditures of \$918,081.00.

At this time Ron Whitmoyer commented that he had not attended the preliminary budget meeting and asked if the township is committed to purchasing the radios for the fire companies in the

township. Ron feels the township should take care of the entire bill for the radios. John commented that he feels the fire companies and the township should share the burden of the costs. Resident Jake Derr shared that he feels it is important for the township to cover the cost of the radios.

John Kintzer made motion to adopt *Resolution 2011 -8* to enact the 2012 Budget. Rick Kramer second the motion, upon a roll call vote John and Rick cast a yes vote, Ron cast a no vote. Ron commented that he voted no due to the fact that the full amount for the radios is budgeted, but the Township is not committed to buying the radios at this time.

**2012 Budget Certification for Sewer Service** – The proposed 2012 budget for all public sewer funds had been advertised as available for public inspection on October 26, 2011, after having been reviewed and preliminarily approved by the Board on October 18, 2011. The 2012 budget for all public sewer funds proposes revenues of \$298,830.00 and expenditures of \$295,500.00. John Kintzer made a motion to adopt *Resolution 2011–9* to enact the 2012 Sewer Budget. Rick Kramer second the motion upon a roll call vote John and Rick cast a yes vote and Ron cast a no vote on the motion.

**Tax Levy Resolution** – This resolution fixed the rate for the year 2012 as follows:

**Real Estate Tax Levy** – remains at 1.6 mills on each dollar of assessed valuation, or the sum of 16 cents on each one hundred dollars of assessed valuation. (\$160 for each 100,000.00 valuation).

Act 511 Per Capita Tax Levy – remains at the rate of \$5.00 payable of all residents 18 years of age or older.

Act 511 Real Estate Transfer Tax Levy – remains at the rate of one half percent.

Act 511 Earned Income Tax Levy – remains at the ratio of one half percent.

Tax Rate for Street Light usage in the Villages of Rehrersburg and Mt Aetna – at the rate of \$.75 for each front foot of property that is serviced by the coverage of such Street Light on each property.

Rick Kramer made a motion to adopt the Tax Levy *Resolution 2011-7* to enact the tax levy for 2012. Ron Whitmoyer second the motion, upon a roll call vote all three Board Members cast a yes vote on the motion.

**Police Contract for 2012-2014** —Rick Kramer made a motion to approve and sign the Police Contract for 2012-2014. Ron Whitmoyer second the motion, upon a roll call vote all three Board Members cast a yes vote.

## **Solicitor Legal Discussions**

An executive session was held to discuss a personnel matter.

Lester Feick also brought to the Board attention some posts that are in the townships right of way on Teen Challenge Road. They are very close to the road and should not be located in the right of way. Harold Shirk is the property owner, the Board of Supervisors directed the township secretary to send a letter to Mr. Shirk notifying posts

It was also discussed that one of the sewer pumps needs to be replaced. John Kintzer will talk to Mike Kreiser about purchasing a new pump.

#### **NEW BUSINESS**

Marion Township Snow Plow – Marion Township has a snow plow for sale and has offered Tulpehocken Township first chance at purchasing it. The price of the plow is \$500.00 and Marion Township is willing to accept in kind services from Tulpehocken Township for the purchase. Ron Whitmoyer made a motion to purchase the plow for in kind services. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote. Township Secretary will send a letter to Marion Township notifying them of the action taken at this meeting.

#### **CORRESPONDENCE**

**Berks County Department of Emergency Services** — Berks County Department of Emergency Services has reviewed the proposed street name "Village Drive" for Village Drive Estates. The Department of Emergency Services cannot approve the suggested street name; it is already being used in Berks County. All three Board Members are in agreement to allow "Village Drive" as the proposed street name.

Chairman Kintzer asked to see the Solicitors bill. Kintzer questioned the charges for the Solicitor to research eligibility and health insurance questions, these business items had been previously taken care of. Chairman Kintzer shared his opinion that these were researched for a personal issue. Ron Whitmoyer commented that he had talked to the Solicitor about these issues and was only following up on the previous decision he felt it was incorrect and asked additional questions. The Solicitor commented that things need to be clarified between Policy and Insurance plan and that the questions Ron Whitmoyer asked are not for personal but for all employees. Ron Whitmoyer stated that he stayed at the meeting for the interest of all employees not his own, so they don't lose health benefits. Also that the township employee handbook states that part time/regular employees are eligible for medical benefits, he helped write and approve this handbook and it does state for medical benefits regular "comma" full time employees are eligible for medical benefits.

After this discussion Rick Kramer made a motion to approve the payments of bill for this December 12, 2011 meeting. Ron Whitmoyer second the motion, upon a roll call vote Ron and Rick vote yes and John voted no. John is opposed to the section previously discussed in Hartman's bill.
