### **Public Comments**

Resident Gerald Derr asked the Board about planning for sewer capacity within Phase II of Mountain Meadows Land Development plan. The Board responded that the Sewer Engineer calculates and monitors the capacity of the plants. Gerald Derr also asked why the Zoning Hearing was cancelled for Thomas Wise was cancelled. Mr. Wise requested the withdrawal of the zoning application with the right to submit at a later date.

Resident Gerald Umbenhauer commented that traffic is still going the wrong way on Mill Street in Mt Aetna.

### **UNFINISHED BUSINESS**

Speed Limit Reduction for Rehrersburg Road – Speed limit study had been completed for State Route (SR) 4008 with regard to a possible reduction in the existing speed limit. As a result of these studies, Penn Dot will establish a 45 mph speed limit on SR 4008 in the area of the existing 55 mph speed limit. The speed limit reduction should be incorporated into the Omnibus Ordinance to insure the police can enforce the speed limit. John Kintzer made a motion to add this new speed limit and any others that may have changed with in the Township, into the Omnibus Ordinance. Dale Swope second the motion, upon a roll call vote all three Board Members cast a yes vote.
