NEW BUSINESS

Tapping Fee Calculation – Current tap in fee is \$2,823.22. The fee was recalculated; this year's tap in fee was calculated to be \$ 2,945.28. John Kintzer made a motion to adopt Resolution 2012-2 setting the new tap in fee at \$2,945.28. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

Police Regionalization – A joint meeting with Bethel Township Board of Supervisors has been scheduled for February 27, 2012 at 7:00 p.m. here at the Tulpehocken Township Municipal Building. Gary Deck made a motion to authorize the Township Secretary to advertise the meeting for the purpose of Police Regionalization. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

Flood Plain Ordinance –Rick Kramer made a motion to authorize the Township Solicitor to advertise the Flood Plain Ordinance for adoption at next month's meeting. Gary Deck second the motion, upon a roll call vote all three Board Members cast a yes vote.

Rural Recycling Program –Berks County is looking to save collection costs by placing one rolloff container at each location permanently and have that container serviced as needed. The Director of the program is requesting either approval or rejection of this change and/or ideas that may improve the program. The Board agreed that this would be a good idea and directed the Township Secretary to find our more information on the changes such as, who schedules pick up when full, response time, will more than one contain by available, and could another location be used for dropping a second container.

Fuel Bid – John Kintzer made a motion to adopt Resolution 2012-3 to award contract for the purchase of gas and diesel through Berks County Joint Purchasing. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

CORRESPONDENCE

Village Estates – Village Estates has decided to use the name of "Chloe Drive" for the proposed cul-de-sac street. This name was available for use as a non-duplicated name from the Berks County 911 Office. Chairman Kintzer commented that the Board had discussed the proposed street name of "Village Drive" the two months prior to this meeting and that the Board agreed this name is not in use in Tulpehocken Township and did not have a conflict with the street name. After discussion it was agreed to have the Township Secretary contact the developer and ask why they are changing the street name. The topic was tabled.

John & Lisa Noecker – John and Lisa Noecker have requested the sewer charges be waived beginning the end of January 2012. Their property at 232B Godfrey Street, Rehrersburg has been vacant since July 29, 2011 and all user fees are paid to date. John Kintzer made a motion to waive sewer charges until property is sold. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.
