January 9, 2012 Board of Supervisors Meeting

Chairman Kintzer called the regular meeting of the Township Board of Supervisors to order at 7:00 p.m. in the Tulpehocken Township Municipal Building. Those attending the regular monthly meeting were John Kintzer, Rick Kramer, Gary Deck, Kathy Boltz, Kris Kerschner, Chris Hartman, Lester Feick, and other interested persons.

The meeting continued with the pledge to the American Flag.

PUBLIC COMMENTS

Little Swatara Creek Bridge Replacement Project – Thomas Cushman from AECOM attended the meeting to inform the public of the bridge replacement project. The project is preliminary Engineering and waiting for environmental approval. The expected bid date is April 2014 or possibly sooner if funding is available. The scope of the project is to replace the narrow 3 span bridge with a span bridge with a 4 foot shoulder on each side and 250 feet of work on each side of the bridge. The project will require a detour and should be done in one construction season. Signs for the detour will be placed in advance. The bridge carries about 4000 vehicles per day.

Herb Zechman, Board of Supervisor from Bethel Township, is concerned with the proposed project detour and how it will affect the response for the ambulance when it is called out. He questioned if a bypass had been considered. The response from Mr. Cushman was that the wet lands restrict permitting for a bypass.

There was also concern about the truck traffic with the detour, Chief Kerschner commented that he can notify the local trucking companies of the detour and request that the drivers follow the detour.

The project display and questioner for residents was left in the meeting room for residence to review and submit any concerns they may have.

Steven Zablocki – Mr. Zablocki resides at 171 Deck Road for 7 years and commented that he works hard to keep his property nice. Mr. Zablocki stated that he filed a written complaint in the Township office for the property across from his driveway, 176 Deck Road. The complaint is that the trash cans lie out at the street; grass is high and has not been mowed in seven months. He shared photos of the property with the Board. Chairman John Kintzer told Zablocki that the Board will look into the issue and will send out code enforcement if there is a problem.

John Kintzer second the motion, upon a roll call vote all three Board Members cast a yes vote. Rick Kramer made a motion to approve the minutes from the January 3, 2012 reorganization meeting. Gary Deck second the motion upon a roll call vote all three Board Members cast a yes vote.

As a result Mr. Whitmoyer was issued a check in the amount of \$322.18 which brings the total amount of reimbursements paid to Mr. Whitmoyer to \$14,392.41.

Police Report –Kris Kerschner read the December 2011 Police report as follows:

UNFINISHED BUSINESS

Dutch Valley EDU Purchase – At the December 2011 Board of Supervisors meeting Larry Martin from Dutch Valley requested and additional eight edu's for the addition to the warehouse. Mr. Martin notified the Board of Supervisors via email that he is reducing the request to four and that the four edu's will continue to be for domestic type flows and will not include food processing waste. The Board had reviewed the current agreements with Dutch Valley and questioned if the on lot septic system had been abandon. The Solicitor commented that DEP regulated industrial discharge differently and the township has the obligation to enforce at the local level. The township rules and regulations have rules on industrial users. The Solicitor recommended sampling the discharge from Dutch Valley. If comingling discharge waste then install sampling pit and do periodic sampling.

John Kintzer made a motion to authorize Ludgate Engineering to investigate if Dutch Valley abandoned the on lot septic system. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

NEW BUSINESS

Uniform Construction Code County Wide Appeals Board – The Township currently has its own Board (Barry Wessner, Dale Stump, and Alan Bashore), the Board of Supervisors decided to keep the Uniform Construction Appeals Board the same and not participate with the county.

Police Regionalization – Herb Zechman, Supervisor from Bethel Township, asked the Tulpehocken Board Members if they will meet with the Bethel Supervisors to discuss a Police Regionalization. All three Tulpehocken Board members agreed to meet and asked Mr. Zechman to propose some dates for the meeting. Mr. Zechman will notify this Board of some possible dates to meet.
