# June 11, 2012 Board of Supervisors Meeting

Chairman John Kintzer called the regular meeting of the Township Board of Supervisors to order at 7:00 p.m. in the Tulpehocken Township Municipal Building. Those attending the regular monthly meeting were John Kintzer, Rick Kramer, Gary Deck, Kathy Boltz, Chad Hepler, Cheryl Allerton, and other interested persons.

The meeting continued with the pledge to the American Flag followed by a moment of silence to reflect on the passing of Bethel Township Police Officer Charles Myers. The Board of Supervisors authorized the Township Secretary to send condolences to Officer Myers family.

## **PUBLIC COMMENTS**

Ruth Moyer asked the Board when a newsletter will be going out, she would like to see a notice about the recycling and the burning ordinance included in the newsletter. The Board is planning on sending out a newsletter and will be sure to include these items.

#### APPROVAL OF MINUTES

Rick Kramer made a motion to approve the minutes from the May 14, 2012 Board of Supervisors meeting. Gary Deck second the motion, upon a roll call vote all three Board Members cast a yes vote.

#### **ADMINISTRATIVE ACTIONS**

### Planning Commission Recommendations to the Board

Camp Calvary – Planning Commission recommended the Board of Supervisors accept a time extension offer until September 11, 2012. Rick Kramer made a motion to accept the time offer extension offer until September 11, 2012. Gary Deck second the motion, upon a roll call vote all three Board Members cast a yes vote.

Conner Subdivision – Planning Commission recommended the Board of Supervisors grant conditional approval upon the conditions in the Ludgate review letter dated June 6, 2012 and E & S approval. Gary Deck made a motion granting conditional approval upon the conditions in the Ludgate review letter dated June 6, 2012 and E & S approval. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

Dieffenbach Chips – Planning Commission recommended granting a waiver of Land Development with the condition that stormwater improvements be noted on the plan to file. of 301.1.M as recommended by the Planning Commission. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote. Gary Deck made a motion to grant a waiver for Land Development upon the conditions in the Ludgate review letter dated June 6, 2012. **Road Master's Report** – Road Master Lester Feick read the May 2012 Road Report. The work consisted of mowing, highway mowing, inspection for sewer, sewer callouts, CDL testing, road project for seal coating, finished off Parkside Inn Road, and attendance at the State Convention.

Lester Feick has gotten prices on sand blasting the dump truck. The Board discussed the prices and asked Lester to also get a price on a new body for the truck. No decision was made at this time.

#### UNFINISHED BUSINESS

**501 Bar & Grill** – There was discussion on the Planning Commission minutes pertaining to the weeds along the alley behind the 501 Bar & Grill. The Board does not feel this is a chronic complaint, no action taken.

**Mountain Meadows** — There was discussion on the Planning Commission minutes pertaining to the homes in Mountain Meadows experiencing low water pressure. No official complaints have been filed with the Township; therefor the Solicitor recommended that we do not take action at this time.

#### **NEW BUSINESS**

**Police Agreement with Tulpehocken Area School District** – Rick Kramer made a motion to authorize Chief Kerschner to sign the Memorandum of Understanding between Tulpehocken School District and the Tulpehocken Township Police. Gary Deck second the motion, upon a roll call vote all three Board Members cast a yes vote.

**Metering Pump Stations** – DEP is unsatisfied with the Chapter 94 Report, and reported there is an outstanding issue with metering at the pump stations. Rick Kramer made a motion to authorize the Township Engineer to meet with DEP to discuss the metering of the pump stations. Gary Deck second the motion, upon a roll call vote all three Board Members cast a yes vote.

**Village Estates** – Township Solicitor drafted and agreement for the EDU reservation and Pump Station for Village Estates. The agreement will be revised to reflect the EDU purchase, the pump station will be dedicated to the Township.

#### **CORRESPONDENCE**

Grace and Earl Miller, 14 West Market Street, Mt Aetna has requested a waiver for the sewer bill as the house has been unoccupied since January of 2012 and is for sale. Gary Deck made a motion to grant a waiver of the sewer user fees until the house is sold or occupied. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

Mt Aetna Bible Church wants to plan a community service project for their Bible School in July. The Township Insurance provider recommends that the Church lists the Township as an additional insurance on their general liability and provide a certificate of insurance to the Township. Also have the participants or participants parent/guardian sign a waiver releasing the Township of any responsibility for injury, and to have the participants where bright colored clothing.
