Earned Income Tax Ordinance – Rick Kramer made a motion to enact ordinance 2011-2. Ron Whitmoyer second the motion. Upon a roll call vote all three Board Members cast a yes vote.

NEW BUSINESS

Designation of Agent – John Kintzer made a motion to adopt resolution 2011-6 designating Lester Feick as agent for Tropical Storm Lee. Rick Kramer second the motion, upon a roll call vote all three Board Members cast a yes vote.

Appointment of CPA Auditor – The appointment of the Township's CPA auditor needs to be advertised 30 days prior to the reorganization meeting along with their applicable fees that will be charges. 2012 Audit fee for Reinzel Kuntz will be \$9,300.00. Rick Kramer made a motion to authorize advertisement of the Resolution to appoint Reinzel Kuntz as CPA Auditor. Ron Whitmoyer seconded the motion; upon a roll call vote all three Board Members cast a yes vote.

Reorganization 2012 – Reorganization meeting will be Tuesday January 3, 2012 at 8:00 a.m. in the Township Building.

Ford Explorer – It was discussed that the new police vehicle has arrived and it was decided to keep the ford explorer for now.

Teen Challenge Sewer Rate – As per the agreement between the Township and Teen Challenge the rate should be recalculated annually. It was discussed that it does not make sense to recalculate every year per cost of calculating. Ron questioned that if this would affect everyone

in the public sewer or just Teen Challenge. The rate change would only affect Teen Challenge; they are a metered customer under a separate contract from the other users.

CORRESPONDENCE

Berks Crime Alert – Berks Crime Alert is asking for contributions to the tip-line and crime stopper organization. Rick Kramer made a motion to contribute \$200.00 to Berks Crime Alert. Ron Whitmoyer second the motion; upon a roll call vote all three Board Members cast a yes vote.

Dennis Fry 121 Godfrey Street, Rehrersburg – Dennis is asking for waiver of sewer bill unitl the house is finished, house has been vacant since June 19, 2009 and there is no plumbing or water hook up in the house. Ron Whitmoyer made a motion to grant the waiver of the sewer bill from tonight until occupied pending inspection of the property. John Kintzer second the motion, upon a roll call vote all three Board Members cast a yes vote. It was also decided that all past due balances are do the Township.

John & Lisa Noecker 232B Godfrey Street, Rehrersburg – Noecker's are asking for waiver of the sewer bill, the house has no one living there. It was discussed that the property has not been vacant for six months. John Kintzer made a motion to deny the request of waiver of sewer bill and send a letter of notification to the Noecker's with a copy of the rules and regulation pertaining to vacant properties. Ron Whitmoyer second the motion, upon a roll call vote all three Board Members cast a yes vote.

At this time Ron Whitmoyer suggested changing the rules and regulation to state that the township will plug the sewer line for properties that are vacant and not being charged user fees until the property is occupied again. The Solicitor commented that plugging and unplugging sewer lines is not the townships burden to carry and did not think this would be a good idea.
