WHEREAS, the Township has retained the services of a certified Sewage Enforcement Officer; and

WHEREAS, the Township desires to adopt a schedule of permit fees.

NOW, THEREFORE, Be it Resolved that the Board of Supervisors of Tulpehocken Township hereby adopts the following fee schedule for Sewage Enforcement Officer's services:

Compensation of the Sewage Enforcement Officer:

The appointed Sewage Enforcement Officer shall be compensated at a rate of \$53.00 or \$59.75 per hour plus out of pocket expenses, including mileage at the prevailing PA DEP rate, and a digging and presoak fee of \$56.00 for each perc test performed.

It is further resolved that the appointed Sewage Enforcement Officer is hereby authorized to collect the above-mentioned fees on behalf of the Township.

All previous Sewage resolutions of Tulpehocken Township are hereby superseded by this resolution.
