**A RESOLUTION OF THE BOARD OF SUPERVISORS OF
THE TOWNSHIP OF TULPEHOCKEN, BERKS COUNTY,
PENNSYLVANIA, APPOINTING WILLIAN GETTEL AS
AN ALTERNATE MEMBER TO THE ZONING HEARING
BOARD OF TULPEHOCKEN TOWNSHIP**

WHEREAS, pursuant to the Pennsylvania Municipalities Planning Code, Section 903(b), the Board of Supervisors may appoint residents of the municipality to serve as alternate members of the Zoning Hearing Board for a term of three years; and

WHEREAS, the Board of Supervisors of Tulpehocken Township intends to appoint William Gettel to the Tulpehocken Township Zoning Hearing Board for a three year term commencing on July 12, 2010; and

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the Pennsylvania Municipalities Planning Code, Section 903(b), the Board of Supervisors resolves as follows:

1. William Gettel, resident of Tulpehocken Township, shall be appointed to the Tulpehocken Township Zoning Hearing Board for a three year term commencing on July 12, 2010.

FURTHER RESOLVED, that this Resolution shall take effect immediately, or as soon as legally permissible thereafter.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Tulpehocken Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section, or part not been included herein.

FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.

FURTHER RESOLVED, that the Township Secretary shall deliver a certified copy of this Resolution to the appointee.
