RESOLUTION NO. 2012-2

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
TOWNSHIP OF TULPEHOCKEN, BERKS COUNTY, PENNSYLVANIA,
INCREASING THE SEWER TAPPING FEE**

WHEREAS, pursuant to the Second Class Township Code, Section 2502, the Board of Supervisors may impose a charge to property owners who desire to or are required to connect to the Township's sewer system a tapping fee among other similar fees; and

WHEREAS, the Board of Supervisors of Tulpehocken Township intends to increase the sewer tapping fee to a rate of Two Thousand Nine Hundred Forty-Five and 28/100 Dollars (\$2,945.28) as recommended by the Tulpehocken Township Engineer.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the Second Class Township Code, Section 2502, the Board of Supervisors of Tulpehocken Township, Berks County Pennsylvania, hereby increases the sewer tapping fee to a rate of Two Thousand Nine Hundred Forty-Five and 28/100 Dollars (\$2,945.28).

FURTHER RESOLVED, that this Resolution shall take effect immediately, or as soon as legally permissible thereafter.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Tulpehocken Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section, or part not been included herein.

FURTHER RESOLVED, that all Motions, Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.
