RESOLUTION NO. 2015-3

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF TULPEHOCKEN, BERKS COUNTY, PENNSYLVANIA APPROVING THE APPOINTMENT OF NANCY SCHOENER AS DEPUTY TAX COLLECTOR BY TULPEHOCKEN TOWNSHIP TAX COLLECTOR, LORI A. DECK, PURSUANT TO SECTION 5511.22 OF THE LOCAL TAX COLLECTION LAW, 72 P.S. § 5511.22.

WHEREAS, Section 5511.22 of the Local Tax Collection Law, 72 P.S. § 5511.22, provides that a tax collector may, with the approval of a taxing district and his surety, deputize in writing one or more deputy tax collectors, who, when so deputized, shall be authorized to receive and collect any or all of the taxes in like manner and with like authority as the tax collector appointing them. Any tax collector, appointing any deputy collector, shall be responsible for and account to the taxing district for all taxes received or collected by his deputy; and

WHEREAS, the duly elected Tax Collector for Tulpehocken Township, Lori A. Deck, desires to appoint a deputy tax collector to serve as tax collector for the Township should she be unable to perform the duties of tax collector; and

WHEREAS, Lori A. Deck desires to appoint Nancy Schoener as Deputy Tax Collector for Tulpehocken Township; and

WHEREAS, Section 5511.22 of the Local Tax Collection Law, 72 P.S. § 5511.22, provides that the tax collector for a jurisdiction may appoint a deputy tax collector with approval of the tax collector's surety; and

WHEREAS, Travelers Casualty, surety for the Tulpehocken Township Tax Collector, approves the appointment of Nancy Schoener as Deputy Tax Collector for Tulpehocken Township; and

WHEREAS, Section 5511.22 of the Local Tax Collection Law, 72 P.S. § 5511.22, provides that the tax collector for a jurisdiction may appoint a deputy tax collector with the approval of the taxing jurisdiction; and

WHEREAS, the Board of Supervisors of Tulpehocken Township as the governing body of the taxing jurisdiction desires to approve the appointment of Nancy Schoener as Deputy Tax Collector by Lori A. Deck, Tax Collector for the Township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the Township of Tulpehocken, Berks County, Pennsylvania, that they approve of the appointment of Nancy Schoener as Deputy Tax Collector for Tulpehocken Township by Lori A. Deck, Tax Collector for the Township.

FURTHER RESOLVED, that this Resolution shall expire upon the occurrence of the earlier of the following: notification in writing of the Tax Collector's removal of Nancy Schoener as Deputy Tax Collector, resignation of Lori A. Deck as Tax Collector for Tulpehocken Township or commencement of the term of a Tax Collector other than Lori A. Deck following the next municipal election.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Tulpehocken Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.

FURTHER RESOLVED, that all Resolutions or parts of any Resolution inconsistent with this Resolution are hereby superseded.

Naming a Deputy Tax Collector does not relieve the bonded Tax Collector of Liability. Local Tax Collection Law makes the Tax Collector responsible for all taxes collected and received by any Deputies appointed. (Local Tax Collection Law, Section 22 [72 P.S. § 5511.22]).

The signing of this appointment does not alter the terms or conditions of the Indemnity Agreement signed by the Tax Collector in favor of the Surety Company, or any indemnification available at law.

In the event of Incapacitation, the Taxing Entity must notify the Surety Company as soon as practicable in the event the Deputy is called to act.
