#### **RESOLUTION NO. 2015-5**

A RESOLUTION OF THE TOWNSHIP OF TULPEHOCKEN, BERKS COUNTY, PENNSYLVANIA, APPOINTING CHRISTY FLAHERTY AS OPEN RECORDS OFFICER FOR TULPEHOCKEN TOWNSHIP AND ADOPTING A REVISED OPEN RECORDS POLICY FOR TULPEHOCKEN TOWNSHIP

WHEREAS, the Pennsylvania Second Class Township Code, Article VI, Section 607, charges Supervisors with the governance of the township, the authority to employ persons as may be necessary for the general conduct of township business, and to perform duties and exercise powers as may be imposed or conferred by law or the rules and regulations of any agency of the Commonwealth; and

WHEREAS, the Pennsylvania Right-To-Know Law, 65 P.S. Section 502(a) provides for the establishment of an Open Records Officer in each township, and Section 504 thereof provides for the adoption and posting of the regulations, policies and procedures in each township; and

WHEREAS, it is essential to the proper operation of the government of Tulpehocken Township, as well as to assure that the laws are faithfully enforced, that there be an appointment of an Open Records Officer; and

WHEREAS, Christy Flaherty is employed by Tulpehocken Township as the Township Secretary Treasurer; and

WHEREAS, the Board of Supervisors desires to appoint Christy Flaherty as the Open Records Officer for Tulpehocken Township; and

WHEREAS, the Pennsylvania Right-To-Know Law, 65 P.S. Section 504 provides for the adoption and posting of the regulations, policies and procedures in each local agency; and

WHEREAS, it is essential to the proper operation of the government of the Tulpehocken Township, as well as to assure that the laws are faithfully enforced, that there be adopted a revised Open Records Policy.

NOW, THEREFORE, BE IT RESOLVED, that the following appointment be made to a Tulpehocken Township appointive office, with the appointee to hold such office until her removal from such office or until her successor shall have been appointed by the Board of Supervisors:

Christy Flaherty is hereby appointed to the office of Open Records Officer of Tulpehocken Township and shall fulfill the duties of Township Open Records Officer set forth in the Pennsylvania Right-To-Know Law.

FURTHER RESOLVED, that such appointee shall serve at the pleasure of the Board of Supervisors of Tulpehocken Township and for an indefinite term in such appointive office.

FURTHER RESOLVED, that the attached Open Records Policy be adopted for the Township of Tulpehocken.

FURTHER RESOLVED, that the above-stated appointment and Open Records Policy shall take effect immediately.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Tulpehocken Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.

FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.

FURTHER RESOLVED, that the Township Secretary shall deliver a certified copy of this Resolution to the appointee.

# **Open Records Policy**

## **Open Records Officer**

#### General

All documents deemed public records shall be available for inspection, retrieval, and duplication at the Municipal Building during established business hours, generally 7:00 A.M. to 3:30 P.M. on Monday, Tuesday, and Thursday, with the exception of holidays.

#### Requests

Requests shall be made in writing to the Township Open Records Officer on a form provided by the Township or the form provided by the Pennsylvania Office of Open Records. (See attached form)

#### Fees

Paper copies shall be 25 cents per page per side. The certification of a record is \$1 per record. Specialized documents including, but not limited to blue prints, color copies and non-standard sized documents shall be charged the actual cost of production. If mailing is requested, the cost of postage will be charged. The Township shall require prepayment if the total fees are estimated to exceed \$100.

### Response

The Township shall make a good-faith effort to provide the requested public record(s) as promptly as possible. The Open Records Officer shall cooperate with those requesting records to review and/or duplicate original Township documents while taking reasonable measure to protect township documents from the possibility of theft, damage, and/or modification.

The Open Records Officer shall review all written requests for access to public records. As soon as possible, but no later than five business days after receiving a written request to access public records, the Open Records Officer shall respond to such requests in writing consistent with Act 3 of 2008, the Right-to-Know Law.

If access to a record is denied, the response shall include a reason for denial as stipulated in Act 3 of 2009, the Right-to-Know Law.

# **Appeals Process**

The appeal shall be filed within 15 business days of the mailing date of the Township's response or within 15 business days of a deemed denial. The appeal shall state the grounds upon which the requester asserts the record is a public record and shall address any grounds stated by the Township for delaying or denying the request.
