### RESOLUTION NO. 2005-12

A RESOLUTION OF THE BOARD OF SUPERVISORS OF TULPEHOCKEN TOWNSHIP, BERKS COUNTY, PENNSYLVANIA AMENDING RESOLUTION NO. 2005-8 AND RESOLUTION NO. 2005-9 AND MODIFYING THE AREA AND DESCRIPTION OF CERTAIN PROPERTY LOCATED IN TULPEHOCKEN TOWNSHIP AND APPROPRIATED AND CONDEMNED FOR EASEMENTS FOR THE TULPEHOCKEN TOWNSHIP WASTEWATER COLLECTION SYSTEM

BE IT RESOLVED by the Board of Supervisors of Tulpehocken Township, Berks County, Pennsylvania and it is hereby RESOLVED as follows:

- 1. Tulpehocken Township, Berks County, Pennsylvania ("Township"), a Pennsylvania township of the second class, by Resolution No. 2005-8, dated June 28, 2005, as amended by Resolution No. 2005-9, DATED July 20, 2005, appropriated and condemned certain real estate located in Tulpehocken Township, Berks County, Pennsylvania, pursuant to the Pennsylvania Eminent Domain Code ("Code"), 26 P.S. § 1-101, et seq., as amended.
- 2. The Township hereby amends Resolution No. 2005-8, as previously amended by Resolution No. 2005-9 to modify the area and description of certain real estate located in Tulpehocken Township, Berks County, Pennsylvania and appropriated and condemned by the Township, pursuant to the Code, as follows:
  - a. Mt. Aetna Trust, 7669 Lancaster Avenue, Tulpehocken Township, Berks County, Pennsylvania, Tax Parcel # 86-4309-07-59-5415:
    - i. the permanent easement appropriated and condemned by Resolution No. 2005-8 is hereby re-located over, across and through that portion of land containing approximately 4.8/0 square feet, as more fully described in Exhibit A-1 and shown in Exhibit B-1, attached hereto and made a part hereof.
    - ii. the temporary easement appropriated and condemned by Resolution No. 2005-8 is hereby re-located over, across and through that portion of land containing approximately 4, 336 square feet, as more fully described in Exhibit A-1 and shown in Exhibit B-1.
  - b. Frank Cronkhite and Amy Cronkhite, 473 Godfrey Street, Rehrersburg, PA 19550, Tax Parcel # 86-4411-16-93-3088:
    - i. the permanent easement appropriated and condemned by Resolution No. 2005-8 is hereby re-located over, across and

- through that portion of land containing approximately <u>4,30.3</u> square feet, as more fully described in Exhibit A-2 and shown in Exhibit B-2, attached hereto and made a part hereof.
- ii. the temporary easement appropriated and condemned by Resolution No. 2005-8 is hereby re-located over, across and through that portion of land containing approximately 652 square feet, as more fully described in Exhibit A-2 and shown in Exhibit B-2.
- c. Gerald G. Lehman and Diane W. Lehman, 6 Goose Run Road, Tulpehocken Township, Berks County, Pennsylvania, Tax Parcel # 86-4400-00-50-5087:
  - i. the permanent easement appropriated and condemned by Resolution No. 2005-9 is hereby re-located over, across and through that portion of land containing approximately 3,825 square feet, as more fully described in Exhibit A-3 and shown in Exhibit B-3, attached hereto and made a part hereof.
  - ii. the temporary easements appropriated and condemned by Resolution No. 2005-9 are hereby re-located as follows:
    - A. over, across and through that portion of land containing approximately <u>/, 232</u> square feet, as more fully described in Exhibit A-3 and shown in Exhibit B-3.
    - B. over, across and through that portion of land containing approximately <u>945</u> square feet, as more fully described in Exhibit A-3 and shown in Exhibit B-3.
- 3. The Township Solicitor and the Project Engineer for the Township's wastewater collection system are hereby authorized and instructed to prepare such documents and plans as may be required to effect the condemnations, as amended and modified hereby.

4. All other provisions of Resolution No. 2005-8 and Resolution No. 2005-9 shall not be modified hereby except as expressly set forth herein.






