Tulpehocken Township Board of Supervisors Meeting of September 14, 2022

The Tulpehocken Township Board of Supervisors met on September 14, 2022, in the Township meeting room at 7 P.M. In attendance and voting were Supervisors: Chairman Gary Deck, Vice Chairman Lester Feick and Supervisor Harold Zimmerman. Also present were Bryan Dronick, Police Chief and Kathy Judy, Township Secretary/Treasurer.

Members of the audience included Margo McQuate, Paul McQuate, Jason Day, Jeffrey Zimmerman, DeVon Henne and Bob Sattazahn.

CALL TO ORDER

Chairman Deck called the meeting to order at 7:00 P.M.

The meeting continued with the pledge to the American Flag.

PUBLIC COMMENTS:

A member of the audience requested discussion of agenda item 11a and asked for an update regarding the Citizen Complaints against 64 Hillcrest Lane. Chairman Deck stated that he did have a conversation with the property owner and also made a visit to the site. The Board has determined that the property owner is not in violation of any use or maintenance ordinances and there is no action the Township can take. The complaint about the property owner's lack of contributing toward the maintenance of the lane and the complaint about the mailbox were also discussed. The Board advised that it could not address those matters; the lane would be a civil matter and the mailbox a civil and/or USPS matter.

APPROVAL OF MINUTES

Vice Chairman Feick made a motion to approve the minutes from the August 10, 2022 Board of Supervisors meeting - - seconded by Supervisor Zimmerman and passed unanimously (3-0).

Vice Chairman Feick made a motion to approve the minutes from the August 17, 2022 Special Meeting - - seconded by Chairman Deck and passed unanimously (3-0).

ADMINISTRATIVE ACTIONS

Personnel:

Vice Chairman Feick made a motion to accept Pat Flaherty's 8/10/22 resignation from the Township Road Crew - - seconded by Supervisor Zimmerman and passed unanimously (3-0).

Supervisor Zimmerman made a motion to ratify payment of Heather Claman's prorated vacation hours - - seconded by Vice Chairman Feick and passed unanimously (3-0).

Planning Commission updates / recommendations:

Shirk Farm Annexation Sketch Plan of Record. In accordance with the recommendation passed by the Planning Commission on September 1, 2022, *Vice Chairman Feick made a motion to approve*

the Plan with the condition that documentation is provided that shows the allocation of future units - seconded by Supervisor Zimmerman and passed unanimously (3-0).

DeVonn Henne, present at the meeting, advised that the documentation has been provided. The Board will review it and, if all the conditions have been met, will execute signing the plan at their meeting on September 19, 2022.

Reaffirm David G. Martin Final Minor Subdivision Plan. Plans were revised to correct a measurement and acreage error. Supervisor Zimmerman mad a motion to reaffirm the plans - seconded by Vice Chairman Feick and passed unanimously (3-0).

Shoestring Lot 5, 10 Stouchsburg Road (Day Residence) Agreement An Agreement for Stormwater Improvements and Controls and Best Management Practices, Operations and Maintenance is being required before construction permit applications can be processed. Mr. & Mrs. Day have signed and notarized the Agreement. Vice Chairman Feick made a motion for the Chairman to sign the agreement - - seconded by Supervisor Zimmerman and passed unanimously (3-0)

Chief Dronick reported that during the month of July there were 144 calls received through Berks County 911 for police service; noting that fifteen (15) of those were for Teen Challenge.

Chief Dronick informed the Board of Supervisors that the Highway Safety Network is extending the grant for the Police Traffic Service Project from 10/01/2022 to 09/30/2023. Supervisor Zimmerman made a motion to sign and submit the Conditions of Agreement Grant Extension - - seconded by Vice Chairman Feick and passed unanimously (3-0).

Chief Dronick advised the Board of Supervisors that The Tulpehocken Area School District would like to know what the hourly rate for Police Services will be in 2023. The Board decided to address the matter at the preliminary budget meeting scheduled for Monday, September 19, 2022.

Chief Dronick informed the Board of Supervisors that he received an email regarding a grant program starting September 15, 2022; the deadline to complete the application for the grant is October 13, 2022. The grant is limited, there are only certain things the funds can be used for and in Tulpehocken's case that would be to help obtain safety equipment. Chief Dronick recommended trying to put in for dash cameras for the police vehicles and upgraded tasers; the tasers we have now are no longer supported by taser and couldn't be repaired if something were to happen to them. Vice Chairman Feick made a motion to authorize Chief Dronick to apply for the grant - - seconded by Supervisor Zimmerman and passed unanimously (3-0).

<u>Roadmaster Report</u> – Vice Chairman Feick read the August, 2022 report. The work consisted of regular monthly sewer meter readings and maintenance, phone calls, lawn mowing, working in the shop, Whitman Road project, call-outs, Church Street sewer project that took about three weeks until complete, highway mowing, met with Louie Hurst at Mt. Meadows and went over the road that's ready to be paved, and manhole testing at Dutch Valley Foods a couple of times.

There was some discussion regarding what the plan is for repairing the road at Mt. Meadows, followed by updates on what work is currently taking place at Village Estates and what the status is there.

<u>Fire Chiefs' Reports</u> – Vice Chairman Feick read the monthly reports for the Keystone Fire Company and the Rescue Fire Company.

The Rehrersburg Annual Car Show was held on Saturday, September 10, 2022. There was some discussion and all agreed that the number of cars, the weather and the number of people who attended were all very good and that the show had a good year.

SEWER OPERATIONS

Judgements and Delinquent Sewer Accounts: Nothing to act on.

Update – Church Street repairs: Vice Chairman Feick advised that the work is done; it took about three weeks to complete the project.

Update - Mt. Aetna Force Main: All of the work is done.

UNFINISHED BUSINESS

Paving Project: The work is complete, PennDOT has issued their Project Approval and Project Completion Reports.

Update regarding the Real Estate Agreement between the Township and the Rehrersburg Lion's Club: Settlement is scheduled for Tuesday, September 27, 2022.

NEW BUSINESS

PA DEP Bureau of Clean Water NOI & Waiver Renewal 2023-2028: Vice Chairman Feick made a motion to authorize the Chairman to sign the completed renewal application and approve submitting the application and fee to the PA DEP - - seconded by Supervisor Zimmerman and passed unanimously.

2023 Minimum Municipal Obligation (MMO) for the Police Pension Plan: The MMO for 2023 was prepared on the 2022 wage figures. The Township's obligation will be \$10,570.00. *Vice Chairman Feick made a motion to accept the MMO in the amount of \$10,570.00 and authorize it to be sent to PMRS - - seconded by Supervisor Zimmerman and passed unanimously (3-0).*

CORRESPONDENCE

PSATS – Health Insurance Cooperative Trust – Ballot for Election of Trustees: Chairman Deck made a motion for the Vice Chairman to sign the Ballot for candidate Shirl Barnhardt for election – seconded by Supervisor Zimmerman and passed unanimously (3-0).

Request for permission for transfer of Liquor License into Tulpehocken Township: Sunoco at 4992 Four Point Road is purchasing a Liquor License for the location and are requesting to transfer it into Tulpehocken. The Township solicitor has advised that a hearing is needed. Vice Chairman Feick made a motion to authorize the Township Solicitor to prepare an application and fee schedule

and to communicate with the Applicant's attorney - - seconded by Supervisor Zimmerman and passed unanimously (3-0).

Supervisor Zimmerman made a motion to authorize the Township Solicitor to schedule and advertise for the hearing - - seconded by Vice Chairman Deck and passed unanimously (3-0).

Upper Bern Twp. request for Fire Police Assistance at Block Party on September 24, 2022. *Vice Chairman Feick made a motion to provide Fire Police Assistance for the event - - seconded by Supervisor Zimmerman and passed unanimously (3-0).*
