Tulpehocken Township Board of Supervisors Meeting of January 2, 2024

The Tulpehocken Township Board of Supervisors met on January 2, 2024, in the Township meeting room at 6 P.M. In attendance and voting were Supervisors: Chairman Gary Deck, Vice Chairman Lester Feick and Harold Zimmerman, Supervisor. Also, present were Michelle Mayfield, Township Solicitor; Bryan Dronick, Police Chief and Kathy Judy, Township Secretary / Treasurer.

<u>CALL TO ORDER:</u> Chairman Deck called the meeting to order at 6:00 P.M.

The meeting continued with the pledge to the American Flag.

<u>PUBLIC HEARING OF ZONING ORDINANCE AMENDMENTS</u>: Chairman Deck began by explaining the need to amend the ordinance to include rules and regulations for solar energy and the creation of a green energy overlay area where solar farms could be allowed within the Township. The Board and Atty. Mayfield answered questions about what the ordinance will allow, what is in place to ensure upkeep and protect against abandonment of any solar farms built. It was also discussed that being in the green energy overlay district should not impact assessment value or Ag Security Preservation status unless the property owner would choose to allow solar facilities to be built on the property.

Chairman Deck gave a brief summary of the Zoning Ordinance amendments for the keeping of domestic farm animals and backyard chickens. Atty. Mayfield read the regulations for backyard chickens in Village Center and Chairman Deck spoke about the amendment to the definition of animal unit in order to make allowances more consistent in the various zoning districts throughout the township.

Atty. Mayfield spoke briefly about the amendments to the Zoning ordinance for wireless communications facilities needed to comply with state law. She explained that they have to do with allowing for small equipment and antenna additions to poles, barns and other existing structures and they are not part of and do not change the Township's existing cell tower regulations in any way.

After confirming there were no more questions, Vice Chairman Feick made a motion to adopt Ordinance 2024-1, amending the Tulpehocken Township Zoning Ordinance of 2013 regarding rules and regulations for solar energy, the keeping of domestic farm animals and backyard chickens and amending the definition of animal unit - - seconded by Supervisor Zimmerman and passed unanimously (3-0).

Supervisor Zimmerman made a motion to adopt Ordinance 2024-2, amending the Tulpehocken Township Zoning Ordinance of 2013 regarding wireless communication facilities - - seconded by Vice Chairman Feick and passed unanimously (3-0).

PUBLIC COMMENTS: Chairman Deck.

<u>APPROVAL OF MINUTES</u>: Vice Chairman Feick made a motion to approve the minutes from the December 13, 2023 Board of Supervisors meeting - - seconded by Supervisor Zimmerman and passed unanimously (3-0).

Chief Dronick reported that during the month of December there were 144 calls received through Berks County 911; noting that fourteen (14) were for Teen Challenge.

Road Master's Report: Vice Chairman Feick read the December, 2023 report. The work consisted of regular monthly sewer work and meter readings, one snow event, meeting with Dalton Zimmerman about trees on West Four Point Road, spreading salt at a fire scene, cleaning trucks, meeting with SmrtGuys about camera system for at the Park, posting notices for the Zoning Ordinance Amendment Hearing, and cleaning gutters.

The Board discussed some cleanup work that will be needed where some trees washed down to the bridge on Midway Road. Vice Chairman Feick also reported that there is no update on the Utility Truck.

Fire Chiefs' Report – Vice Chairman Feick reviewed activity for the Keystone Fire Company and read the report for the Rescue Fire Company for December, 2023.

Chairman Deck addressed the audience and asked for their thoughts and feedback on a possible tax being put in place to help fund fire and ambulance emergency services. Some discussion followed. Workshops will likely take place this year to develop a plan and have something in place before next year.

Supervisor Zimmerman made a motion to accept the quote and authorize the system upgrade work - - seconded by Vice Chairman Feick and passed unanimously (3-0).
