In attendance and voting were Supervisors: Chairman Gary Deck, Vice Chairman Lester Feick and Harold Zimmerman. Also present were Atty. Michelle Mayfield, Township Solicitor and Kathy Judy, Township Secretary/Treasurer. There were no members in the audience.

CALL TO ORDER: Chairman Deck called the meeting to order at 6:05 P.M.

OTHER BUSINESS:

- **Municipal building carpet cleaning:** The Municipal building steam cleaning quote for 2025 is \$452.00 (a \$33.90 increase from 2024). *Supervisor Zimmerman made a motion to accept the quote and schedule Martins' Floor Coverings to clean the carpets - - seconded by Vice Chairman Feick and passed unanimously (3-0).*
